### Shortage of Antimicrobial Agents Used in Tuberculosis (TB) Treatment Update

A National Patient Safety alert <u>NatPSA/2025/004/MVA</u> was issued on 29th July 2025 regarding intermittent shortages of antimicrobial agents used in the treatment of TB. As per NHS Grampian <u>Shortage Guidance</u>, a Medicines Advisory Group (MAG) is leading on the organisation response to this shortage.

Due to the potential implications of this shortage an Expert Working Group (EWG) has been appointed and met on Thursday 14th August 2025.

### For current patients receiving treatment for TB:

- It is important that there is no interruption to their treatment course, as this risks treatment failure and resistance.
- This is an intermittent supply issue, community pharmacies are encouraged to check wholesalers/order on a regular basis as availability is likely to fluctuate.
- Information regarding availability of unlicensed supplies is currently being collated and will be shared when finalised.
- Please contact the TB nursing team if you have urgent individual TB patient treatment queries and <u>gram.medicinesmanagement@nhs.scot</u> if you require information regarding current known unlicensed suppliers.

Further information will be shared following MAG/EWG meetings as appropriate.
