Reminder: Antivirals for Patients at High Risk of Complication from Covid-19

Please find attached a reminder of the letter regarding Antivirals for Patients at High Risk of Complication from Covid-19 shared previously on 10th June 2025, following a recent increase of cases.

National Patient Safety Alert (NPSA): TB Medicines

Following the release of a NPSA on 29th July a Pharmacy Medicines Shortages Group (PMSG) and Expert Working Group (EWG) were enacted to co-ordinate the NHS Grampian response to the NPSA.

The EWG have reviewed the NPSA and provided information on management of patients who may require impacted medicines for the duration of medicine supply issues.

For Community Pharmacy PMSG would like to highlight the following points:

- Where patients are unable to source medicines to continue treatment, contact should be made with the patients GP practice to advise of patient and when treatment is due to run out.
- Patients prescribed oral tablets should not be switched to liquid medication these supplies must be conserved for paediatric populations only.

Treatment prioritisation is attached for your information.

Reminder: NHS Grampian Community Pharmacy Feedback on Managing Missed **Doses of Opioid Replacement Therapy**

As part of the substance use level one SLA pharmacies are required to participate in quality improvement and audit activities. To help us gather feedback and identify potential areas of improvement we ask that all pharmacies who are signed up to the level one substance use SLA take the time to complete the below survey.

The survey only needs to be completed once on behalf of each pharmacy. It does not have to be completed by a pharmacist but must be completed by a staff member with sufficient training and understanding of the SLA and the process for responding to missed doses of opioid replacement therapy. It should be reflective of the wider teams' processes. There are some questions that may be best completed after discussion within teams.

PCR Errors

Please be reminded of the common errors which may affect your payments:

- Opening another PCR file for a patient within a week is the most common error we see in the data. (Although PCR will accept this, the National database will not recognise a patient with 2 entries within a week and you will not be paid for either).
- **Incorrect phone numbers**. Please do not put the pharmacy number in as the patient's number. If your patient does not have a phone number put UNKNOWN.
