# MHRA Drug Safety Update - Paracetamol in Pregnancy

Please click here to view the MHRA Drug Safety Update on Paracetamol in Pregnancy.

Patients should be reminded and reassured that there is no evidence that taking paracetamol during pregnancy causes autism in children. Paracetamol is recommended as the first-choice pain reliever for pregnant women, used at the lowest dose and for the shortest duration. It also acts as an antipyretic and is therefore used to treat fever.

# NHS Grampian Asthma Management & Prescribing Guidance Update

Following an update to NHS Grampian Asthma Management & Prescribing Guidance (find attached) there has been a changed to the preferred beclometasone/formoterol pMDI inhaler. The brand of choice is now Proxor® (previously Luforbec®).

What does this mean for community pharmacy - from this week you may start to see prescriptions for Proxor<sup>®</sup>. NHS Grampian is not proactively switching patients so this is not expected to be a rapid change over however community pharmacy should be alert to these changes.

Find below an excerpt from the Respiratory Management Clinical Network newsletter which provides some rationale behind the change:

The Respiratory MCN supports the use of the most cost-effective devices to deliver inhaled therapies. Due to an evolving market and ongoing financial pressures within NHS Grampian more frequent changes to preferred products will be required to try and reduce the overall costs of inhaler treatments. Any recommendations for changing to an alternative product would be assessed by the MCN Prescribing Subgroup and would ensure that the same or very similar medications are being given through a suitable device. We would welcome support with accepting these changes if and when they arise.

## **Tramadol MR Prescriptions**

It has been brought to our attention that modified release tramadol is often prescribed generically, but there are a number of different brands on the market with different release formulations - some are 12hrly release and some are 24hr release. The intended release should be checked with the prescriber if it is not clear on the prescription, to ensure the correct formulation is supplied.

The BNF recommends: "Modified-release preparations are available as 12-hourly or 24-hourly formulations. Non-proprietary preparations of modified-release tramadol may be available as either 12-hourly or 24-hourly formulations; prescribers and dispensers must ensure that the correct formulation is prescribed and dispensed. Branded preparations that should be given 12-hourly include Brimisol® PR, Marol®, Maxitram® SR, Tilodol® SR, Tramquel® SR, Tramulief® SR, Zamadol® SR, and Zydol SR®. Preparations that should be given 24-hourly include Tradorec XL®, Zamadol® 24hr, and Zydol XL®."

Public Health Scotland closed both the TRAVAX and Fit for Travel websites on 22<sup>nd</sup> September 2025.

As part of this process:

- All active TRAVAX subscriptions will be refunded in full. Refunds will be processed automatically, and confirmation will be sent once complete.
- The Fit for Travel website will no longer be accessible after this date.

We recognise that these resources have been widely used and highly valued by travel health professionals for many years. To support continuity of practice, we encourage you to access <u>Travel Health Pro</u>, which provides comprehensive, evidence-based travel health guidance, vaccine recommendations, country information, and clinical updates.

# Reminder: NHS Grampian Community Pharmacy Feedback on Managing Missed Doses of Opioid Replacement Therapy

As part of the substance use level one SLA pharmacies are required to participate in quality improvement and audit activities. To help us gather feedback and identify potential areas of improvement we ask that all pharmacies who are signed up to the level one substance use SLA take the time to complete the below survey.

The survey only needs to be completed once on behalf of each pharmacy. It does not have to be completed by a pharmacist but must be completed by a staff member with sufficient training and understanding of the SLA and the process for responding to missed doses of opioid replacement therapy. It should be reflective of the wider teams' processes. There are some questions that may be best completed after discussion within teams.
