Smoking Cessation Update

Project SIMD

According to ASH Scotland, there is a smoking prevalence of 25% in the most deprived areas (SIMD1) compared to 7% in the least deprived areas (SIMD 5).

In line with the Scottish Government initiative to improve quits in these groups, we aim to increase smoking cessation support in pharmacies who sit in SIMD 1 and 2 areas, under an assumption that most patients will visit their local pharmacy and therefore will live in the same SIMD area.

34 pharmacies in Grampian (26%) sit in SIMD 1 and 2 areas. (18 in Moray and North and 16 in Aberdeen City and South Aberdeenshire). If your pharmacy sits in these areas, you will receive an email from your Public Health Practitioner to set up an appointment early in 2026 to look at ways you can improve services and increase successful quits. Please respond to the email in a timely manner.
