Pharmacy First Plus Revised MOU and Ad Hoc Offer

Please find the attached correspondence in relation to the Pharmacy First Plus service and recent circular published on 31st October 2025.

Please note the two actions below:

- **ACTION:** Due to amendments as detailed within the above circular and to our NHS Grampian Pharmacy First memorandum of understanding (MOU) (attached), all Independent Prescribers (PIP) must return an updated and signed copy of the MOU to gram.pharmaceuticalcareservices@nhs.scot
- **ACTION:** If you have a pharmacy that fits the criteria of ad hoc offer of PFP. A separate MOU (Attached) must be complete and returned by each PIP to gram.pharmaceuticalcareservices@nhs.scot

We do recognise that PIPs may not have the individual City, Shire or Moray prescription pads already and it will take time for them to be ordered and arrive. Therefore in consideration of this, prescribing may continue over the busy winter period until we receive updated paperwork. We are allowing PIPs until the end of February 2026 to comply with this requirement.

Smoking Cessation Update

Project SIMD

According to ASH Scotland, there is a smoking prevalence of 25% in the most deprived areas (SIMD1) compared to 7% in the least deprived areas (SIMD 5).

In line with the Scottish Government initiative to improve quits in these groups, we aim to increase smoking cessation support in pharmacies who sit in SIMD 1 and 2 areas, under an assumption that most patients will visit their local pharmacy and therefore will live in the same SIMD area.

34 pharmacies in Grampian (26%) sit in SIMD 1 and 2 areas. (18 in Moray and North and 16 in Aberdeen City and South Aberdeenshire). If your pharmacy sits in these areas, you will receive an email from your Public Health Practitioner to set up an appointment early in 2026 to look at ways you can improve services and increase successful quits. Please respond to the email in a timely manner.

Gold Pharmacies Validation for 2026/27

Remember this is a team award and everyone should be competent with the MEOC ethos, delivering VBA and using the referral pathway. Any staff member may be questioned about their role in achieving the GOLD award.

If you are successful, we'll present your certificate and badges and take your photo for our own socials (with your permission). If you are not successful, we will offer some actions and return to review your status at a later arranged date.

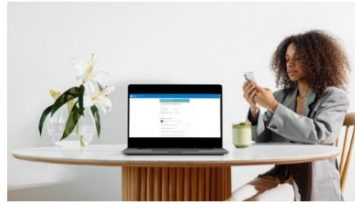

Our colleagues at Strathclyde University are undertaking the following research project



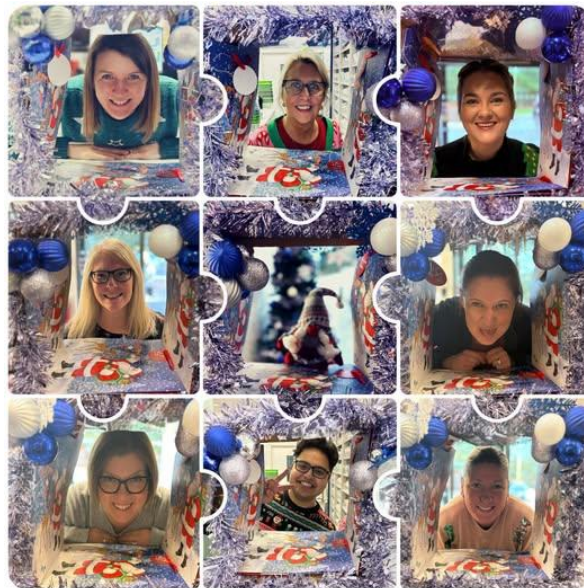
