Reminder: Prescription Stationery - CP4/3 Paper Type Change

Please be reminded of the 2024 circular advising community pharmacy contractors of changes to NHS prescription stationery for the CP4/3 prescription form. This circular advises on the introduction of the ePharmacy CP4/3 form which allows community pharmacies to manage and deliver pharmacy-led services from their Patient Medication Record (PMR) system. This replaces the hand-written CPUS form.

Smoking Cessation Update

Smoking Cessation Services Data Successes

Last week we shared the data for Quarter 2 (July - Sept 2025) which unfortunately showed a decline in sign-ups and successful quits and a rise in missed 4 week submissions to an all-time high.

Today we highlight the pockets of great work by pharmacies who had a decent amount of sign ups, **zero missed submissions** (at 4 and 12 weeks) and a high percentage of successful quits. They are:

- Torry Pharmacy – 7 sign ups and 6 successful quits, 86% success, very well done Team Torry!
- Bairds, Fraserburgh – 7 sign ups with 4 successful quits, 57% success!
- Websters, New Pitsligo – 6 sign ups with 3 successful quits, 50% success!
- Buckpool Pharmacy – 10 sign ups with 4 successful quits, 40% success!

Also well done to Garthdee, Cults, Clear Aberdeen and Kemnay Pharmacies who only had 4 sign ups but an impressive 75% success rate with no missed submissions.

Locum Responsibility to Complete PCR Entries

As mentioned in newsletter dated 20.01.2026, the most recent smoking cessation data showed missed 4-week submissions during July to September 2025 to be at an all-time high of 27%, a loss to you collectively of £3390.

It's been repeatedly mentioned that missed submissions can happen when pharmacies are short staffed and are using a lot of Locum pharmacists. Therefore, please can we remind all locums that you have a responsibility to ensure all your smoking consultations are entered onto PCR and to check for any submissions which are due whilst you are on shift.
