

## Guide Prices for Commonly Requested Unlicensed Medicines

Effective from 1<sup>st</sup> April 2025, any patient presenting with a prescription for the items below, please use the prices and information below to procure and endorse unlicensed specials or imports. If you can obtain at this price or lower, you do not need to seek authorisation.

The prices on the pre-approved guide price list are to provide a maximum cost where the Board are happy to approve without prior authorisation; these do not and should not replace the invoice price submitted for payment. Pharmacy teams must ensure that the item is correctly endorsed electronically (and on paper) as per invoice price and not as listed below.

**NB** Updated circular in respect to Special preparations issued April 2023 – where a product is listed in Part 7S for a liquid or soft-paraffin-based product, that price applies to equivalent suspensions, solutions and products with a white or yellow soft paraffin base, respectively <a href="PCA2023(P)17.pdf">PCA2023(P)17.pdf</a> (scot.nhs.uk)

If the guide price provided cannot be met or if the drug prescribed is not on the list below, then **authorisation will be required.** In these situations, please submit the authorisation request form and email from your NHS generic mailbox to <a href="mailto:nhsh.cpsoffice@nhs.scot">nhsh.cpsoffice@nhs.scot</a>

For products available from an NHS manufacturing unit, such as the Pharmaceuticals Specials Service (PSS, formerly Tayside Pharmaceuticals), no authorisation is required.


## Commonly prescribed vitamins and supplements

Some of these items are not classed as medicines but fall under pay and report mechanisms. Where there is a licensed preparation, this is listed within the expected cost column. To help make things less confusing for contractors, we include these in our authorisation processes as PSD will refer contractors back to their Board for approval.

In general patients should be advised to buy vitamins and food supplements for the purpose of supplementation. They should only be prescribed for proven deficiency or for the treatment of conditions, not for supplementation.

Medical treatment should always use licensed medicines wherever possible, and this is the case for most patients. Please note that the MHRA Guidance Note 14 – The supply of unlicensed medicinal products ("specials") (Appendix 2) sets out the hierarchy of risk for the supply of unlicensed medicines that should be followed. A simplified diagram of the hierarchy is shown below:



Unlicensed medicines do not have a marketing authorisation in the UK and may not have been assessed by the MHRA. Regulation 167 of the Human Medicines Regulations 2012 allows for unlicensed medicines to be supplied when there are no licensed available medicines that can meet the needs of individual patients.

The needs of individual patients must be clinical in nature and are determined by the prescriber responsible for their care.

## How to identify a licensed medicine

It is not always clear if the product you are supplying holds a product license. The Marketing Authorisation number on the outer packaging will take one of two different formats, depending on when the medicine was authorised:

- medicines with a PLGB prefix, for example PLGB/12345/12340, were authorised for the Great Britain (GB) market before 1 January 2025 but are now valid for the whole of the UK
- medicines with a PL prefix, for example PL/12345/12340 have UK-wide Marketing Authorisations.

From 1 January 2025, all UK-licensed medicines must bear 'UK only' on the outer packaging.

There may be medicines without 'UK only' available on the UK market for a period until their expiry date. If obtained from bona fide sources, these medicines can continue to be used until their expiry date.
